#### Terms and Conditions: -

- 1) The said recognition will remain on non-subsidy basis forever.
- 2) In the present case the concerned institution shall be bound to fulfil the conditions prescribed by the Pharmacy Council of India, New Delhi as well as prescribed by the Government Order dated May 21, 1983.

THE REPORT OF THE PARTY OF

- 3) The eligibility of the institute for the said course shall be as mentioned in the attached Annexure A and B.
- 4) The institution must enter into an agreement to accept all the terms and conditions prescribed by the Government as well as prescribed by the Pharmacy Council of India, New Delhi. Also related documents and formalities will be satisfactorily completed with the approval of Director, Technical Education, State of Maharashtra.
- 5) The concerned institution should pay the necessary accumulated deposit to the joint account with the Director, Technical Education and fulfil other legal matters.
- 6) Admission to the said Diploma / Degree / Post Graduate course will be done as per the admission rules / procedure of the relevant course approved by the Government.
- 7) Action will be taken against the concerned Institutions as per Maharashtra Educational Institutions (Prohibition of Capitation Fees) Act, 1987 if the concerned institutions charge more than the education fee prescribed by the Fee Regulatory Authority.
- 8) The Institute should appoint full time teaching staff and other technical staff as per the Government rules to run the course. They should be given wages and allowances to the employees as per rules regarding salary and allowances etc. of teaching staff and other employees Strict action will be taken against the Institution if there are any complaints from the students to the Government.

- 9) Books, Periodicals required by the library in the Institute All India Technical Education Purchases must be made as per council standards. Also, for students to make full use of the library, it is necessary to provide textbooks to the students in the library. Also, students are required to maintain all educational facilities (e.g. Laboratories, Library, Classrooms etc.) as per All India Technical Education Council standards.
